Official Rules

- 1. Sponsor.** The “Cayman Getaway” Sweepstakes (the “Promotion”) is sponsored by Cayman Islands Department of Tourism, Suite 4620, Empire State Building, 350 Fifth Avenue, New York, NY 10118 (“Sponsor”).
- 2. Eligibility.** The Promotion is open only to legal residents of the 50 United States and the District of Columbia, who are twenty-one (21) years of age or have reached the age of majority in their state of residence as of the date of Entry (“Eligible Person”). Must have a United States passport that is valid for 6 months post-travel date of Prize (defined below). Employees, officers, directors and agents of Sponsor and its affiliates, partners, advertising and Promotion agencies, any agencies involved with administering the Promotion, manufacturers or distributors of Promotion materials (“Promotion Entities”) and each of their respective immediate family members (i.e., parents, children, siblings, spouse, and the “steps” of each) or members living in the same household of each (whether related or not) are not eligible to participate.

- 4. Promotion Period.** The Promotion begins at 8:00 AM Eastern Time (“ET”) on February 7, 2026 and ends at 11:59 PM ET on February 18, 2026 (“Promotion Period”).
- 5. Winner Selection.** On or about March 7, 2026 Sponsor will select one (1) potential winner in a random drawing from among all eligible Entries. Sponsor is responsible for determining the winner in its sole discretion, subject to these Official Rules. Odds of winning a Prize depend on the total number of eligible Entries received during the Promotion Period. Potential winner is subject to verification, including verification of age.

6. **Prize.** One (1) winner shall receive: a seven (7) night trip to Grand Cayman for winner and one (1) guest ("Prize"). The dates of the trip must occur between March 8, 2026 through March 31, 2026 or January through March 31, 2027. The dates of the trip may not occur from April 1, 2026 through December 31, 2026 or 2027. Prize consists of (a) roundtrip economy air transportation for winner and one (1) guest via to/from Dallas International Airport only DFW, (b) ground transportation to/from the airport in the Cayman Islands to Grand Cayman Marriott Resort (c) one (1) standard Deluxe Room at Grand Cayman Marriott Resort, The total approximate retail value of the Prize is \$5,700 USD. Travel and hotel accommodation must be reserved through Sponsor or otherwise as directed by Sponsor, in its sole discretion. Additional Terms.** The Released Parties are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, web site, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of Entry information (regardless of cause) which may limit one's ability to enter the Promotion, including any injury or damage to participant's or any other person's computer relating to or resulting from participating in this Promotion or downloading any materials in connection with this Promotion. Sponsor is not responsible if Promotion cannot take place or if any Prize cannot be awarded due to travel cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather, acts of terrorism or any other causes beyond Sponsor's reasonable control.
